 - a) The bidder quoted rates below 10% of the TS shall be required to provide differential amount (between TS and bid) in shape of CDR. from any schedule bank of Pakistan.
 - b) In case of failure to produce the required differential amount of the bid by the bidder along with his bid documents, the bid shall be rejected.
