- The Bids must be submitted via PPRA-EPADS (Scanned Copy) and Original Bids must be submitted in two sealed envelope separately marked as Technical and Financial Bids with single outer envelope in the office of Director Engg-I at PHA Foundation, located on the First Floor of Shaheed-e-Millat Secretariat, Jinnah Avenue, Blue Area, Islamabad.
- The Bid security must be attached with the Technical Bid and scanned copy be uploaded on PPRA-EPADS
  and original be submitted in sealed envelope along with Technical Bid.
- 7. All bids must be submitted in accordance with the instructions in the Bidding Documents on or before 03-07-2024 till 1300 hours. Technical Bids will be opened on the same day at 14:00 hours by the bid opening committee in the committee room at PHAF in the presence of prospective bidder or their representatives.
- In case of any ambiguity / discrepancy in hard and soft form, the bid shall be deemed rejected and nonresponsive.
- 9. Incomplete, conditional, and Bids without required Bid Security shall not be considered.
- 10. No bid through Fax, Telephone, and Telex would be entertained.
- 11. No bidding Documents shall be available for download on the date fixed for the opening of bids.
- The bidder shall submit the NTN/Registration certificate from Income Tax Department along with income tax submission or valid exemption certificate.
- 13. Incase of any unforeseen reasons, public holiday or force majeure on the bid submission and opening date, the Bid shall be submitted and opened on the next working day at the same place and time.
- 14. In case of false information provided by the bidder the concerned firm will be blacklisted/debarred under PRRA rules, decision of the employer in the case should be final.
- All the prevailing PPRA Rules/Act and government notifications issued from time to time will be applicable.
- 16. All the Federal taxes/duties will be deducted from the bills of the contractor at prescribed rates as per government policy issued from time to time.
